



LIMITED WARRANTY & REMEDY

This is to certify that Arch Aluminum & Glass Co. Inc. (Arch) warrants to its dealers, customers and all subsequent purchasers and users, subject to every term, condition and limitation stated herein, that the products supplied by it shall be free from material defects in materials and workmanship for a period of two (2) years from the date of shipment of the products from Arch Aluminum and Glass plant.

This warranty applies only if Arch's products are installed and maintained according to Arch's recommended practices and installation instructions, and only to defects appearing within two (2) years from the date of shipment from and only Arch is notified in writing within sixty (60) days after such defects (a) appear or (b) should have been discovered after the exercise of reasonable diligence. Failure of the claiming party to notify Arch within such period shall automatically relieve Arch of any and all responsibility and/or liability under this Limited Warranty. ARCH DOES NOT MAKE ANY OTHER REPRESENTATIONS OR WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

This warranty does not cover, and Arch hereby disclaims all liability for, the installation of Arch products, any particular application or selection of the product for any particular project or design, any parts gaskets, glazing materials components or sealants of other manufacturers used with Arch products, or any lack of performance of Arch products attributed to such items. This warranty also does not cover, and Arch hereby disclaims all liability for, any product which has been subject to abuse, alterations, neglect, misuse, abnormal use, accident, fire, war, flood, earthquakes, acts of God, or to which parts, not supplied by Arch have been added, or to defects caused by depreciation or normal wear. All decisions regarding the existence of defects in material and workmanship and the occurrence of any of the matters described in the preceding paragraphs or affecting this Warranty shall be made by Arch and shall be binding upon both parties.

The sole and exclusive remedy with respect to this warranty or with respect to any other claim relating to defects or any other condition or use of the products supplied by Arch, however caused, and whether such claim is based upon warranty work. At no time does this confer upon the claiming party or any other party the right to proceed with repair, replacement or restoration, without written notice and agreement by a duly authorized officer of Arch. Any such work undertaken by the claiming party or any other party shall be for the claiming party's account and shall result in this warranty becoming null and void.

ARCH'S AGGREGATE TOTAL CUMULATIVE LIABILITY UNDER THIS WARRANTY IS LIMITED TO THE DOLLAR AMOUNT OF THE PURCHASER'S ORIGINAL PAYMENT MADE TO ARCH FOR MATERIAL FURNISHED BY ARCH ONLY. IN CONSIDERATION OF THE WARRANTY, ARCH SHALL NOT BE LIABLE FOR SPECIAL, DIRECT, INDIRECT OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO LOSS OF USE, LOSS OF PROFITS OR GOODWILL, DAMAGES FOR NEGLIGENCE IN THE MANUFACTURE, DESIGN OR INSTALLATION OF THE PRODUCTS, OR OTHER COMMERCIAL LOSS OR INJURY.

This is the only warranty made in connection with the sale and distribution of the Products. No representative, dealer or any other person is authorized to make or makes any warranty, representation or promise with respect to Products. No terms or conditions other than those stated herein, and no agreement or understanding, oral or written, in any way purporting to modify this warranty shall be binding on Arch unless made in writing and signed by Arch's authorized representative.
